## **ORDINANCE – 144**

(Application for affiliation under section 34 of the Saurashtra University Act- 1965)  
 Application for Affiliation **OR** Extension of Affiliation **OR** Continuation of Affiliation **OR** Bifurcation of an Existing College **OR** Adding New Faculty / Course in an existing affiliated College shall be sent to the Registrar in the form prescribed by the Syndicate so as to reach him as under :
